#### **OUR HISTORY**

The Foundation for Holocaust Victims was established on 31st July 2000 by the Federation of Jewish Communities in the Czech Republic on the basis of the recommendations of the Joint Working Committee Focusing on Mitigating Some Property Injustices to Holocaust Victims. The Joint Working Committee was established on the basis of the resolutions of the Washington Conference on the Property of Holocaust Victims (1998) by Dr. Pavel Rychetsky, the Deputy Prime Minister at that time. The Committee, under the leadership of Dr. Pavel Rychetsky, focused on the studies of the history of the Nazi persecutions of the Jews, and specifically the racial persecution of immovable property within the territory of the Czech Republic. The Committee presented proposals to the government, which would enable the mitigation of some property injustices to Holocaust victims or their descendants.

The Committee also initiated the approval of Law No. 212/2000 Coll. The Czech Parliament approved this Law On Mitigating Some Property Injustices Caused by the Holocaust on 20th June 2000. Based on this resolution, the Chamber of Deputies and the Czech Parliament made a decision, on 15th September 2000, to transfer funds amounting to CZK 300 million over to the Foundation for the Holocaust Victims.

In the period of 2001 to 2005, we administered the Compensation Programme. With a total amount of CZK 100 million, we compensated people who, as a result of racial persecution during the occupation of today's Czech Republic by Nazi Germany, had been deprived of their immovable property, and whose property was not returned to them according to valid restitution regulations, foreign claims settlements, or other forms of compensation.

#### **PRINCIPAL EVENTS IN 2010**

#### 27 January 2010 Ceremonial Commemorative Event in the Czech Senate

This event on which the Shoa survivors traditionally meet on the premises of the Czech Senate under the patronage of its president, Dr. Premysl Sobotka, was organized by the FHV and the Federation of Jewish Communities of the Czech Republic. The function was also attended by Jan Fischer, the prime minister at that time, representatives of the government, ambassadors, and representatives of the Jewish and Roma organizations. The speeches were addressed by Premysl Sobotka, Felix Kolmer, Karel Holomek, Jiri Danicek and Jan Fiscaher, who concluded with the following words: "The Holocaust was pure evil. Holocaust IS pure evil. However, it was possible to prevent it. It IS possible to prevent it. Despite all its breathtakingly devilish perfectness and inhuman haughtiness, the new appearance of evil is always dependent on imperfect and lowly human beings. On human beings. Because humans were fascinated by evil in one instance, we got close to hell, much closer than we ever managed to get to heaven even in thousands of years. But it was our will that drew us to destruction. Our indifference, that paralysed us and prevented us from searching for refuge. Our responsibility, our blame. Nothing but our responsibility and our blame. Back then, as well as today. Forever. For behold, we have a soul. We have freedom. Let us use these gifts and let us prevent evil from rising again. It is our duty because of the Shoa victims. It is our duty because of our children."

## 24 January 2010 Jewish traditions I

"Jewish customs and traditions" – this was the topic of a seminar we organised on the premises of the Prague Jewish community for the staff of Jewish communities and partner organisations. The participants of the seminar were welcomed by the chief rabbi Karol Sidon. The lectures included the topics of Jewish holidays (Tereza Gafna Vanova), kosher food (Irena Svabova) and Jewish rites of passage (Chaim Koci). The seminar was attended by over 60 participants.

## 11 April 2010 Yom ha-Shoa

The 4th year of the Namesti Miru public reading of the names of Shoa vicitims was traditionally co-organised by the FHV and The Institute of Terezin Initiative. The public commemoration event was attended by several hundreds of people. The names were read by Shoa survivors and public figures, such as Tana Fischerova, Marta Kubisova, senator Tomas Topfer, Milan Hein - director of the Ungelt theatre, Jana Cernochova – a former mayor of Prague 2, representatives of the Jewish and Roma communities, and many others. The students of the Lauder Jewish Day School presented their project entitled "Justice in the times of Injustice" during the event.

## 1 July 2010 Calls for proposals within the CARE, REMEMBRANCE, FUTURE and RENOVATION Programmes

We announced the 10th call for proposals for support of projects within all our programmes. The deadline for proposals was set for 17 September 2010.

## 1 September 2010 Seminar for applicants

We organized a seminar for the FHV grant applicants in all our programmes.

## 6 September 2010 Jewish traditions II

Following a massive interest in our first seminar on the topic, we organised a sequel. The welcoming note was addressed by rabbi Sidon. Chaim Koci presented a follow up on his first lecture on Jewish rites of passage, Ales Koukal lectured, on the premises of the High synagogue, about the topic of Synagogue, and Pnina Rubesch presented a lecture on The Land of Israel in the eyes of the Jewish tradition.

#### 27 - 31 October 2010 Eleven Shoa survivors in Israel for the first time

A donor, David Thoma, sponsored the first visit to Israel for eleven Shoa survivors, and two nurses, from the Ostrava Tikvah Home Care Centre. The group stayed in the centre of Jerusalem and toured the Old Town, Yad Vashem Memorial, Masadah and the Dead Sea. The FHV helped with the logistics of the tour.

## 29 - 31 October Board meeting of Internationales Auschwitz Komitee (IAK)

Forty representatives from twelve countries met during the Board meeting of IAK in Berlin. The IAK board, headed by its president Noah Flug, discussed their work and activities. The deputy director of the State museum of Auschwitz talked about the plans for their exhibition renewal. Other participants presented reports of the activities of their organisations. The Czech Republic was represented by Asaf Auerbach (Czech Auschwitz Committee), Jiri Cistecky (European Shoah Legacy Institut) and Marta Mala (FHV). The Board was received by the President of Germany, Christian Wulff.

## 7 November 2010 International Day of Jewish Studies

Lauder Schools of Prague and the FHV co-organised a day of study for adults and children. The adults had a chance to listen to lectures of Chief Rabbi Karol Sidon, rabbi Menachem HaKohen and rabbi Dushinsky. Children took part in a programme that was prepared for them by the Chinuch organisation and the Gan Jehuda kindergarten. The event was attended by 40 adults and 30 children.

#### 18 November 2010 Allocation of grants for 2011

The FHV Board of Directors allocated grants for the projects implemented in 2011. The fund supported 77 projects with a total sum of 15 million CZK.

#### 23 November 2010 Benefit concert

The 5th benefit concert was held in the Roxy Club, Prague. The concert was launched by the cellist duo Dominika a Jiří Hoškovi, who were followed by the Pressburger Klezmer Band with a series of traditional Jewish songs, and by Iby & Chipsy Empire with a mix of Roma music. The evening was moderated by Ester Janeckova.

The visitors had the chance to taste quality coffee, special home-made sandwiches and selection of kosher wines from the partner organisations Mamacoffee, Polevkarna and Ceske vinarstvi Chramce.

The fund managed to raise 38,368 CZK during the concert and wishes to thank all partners and donors - Sdruzeni pro usteckou synagogu a hrbitov, Conseq, AST Kosher food, the Israeli Embassy in Prague, Radio 1, the Federation of Jewish Communities, and all concert visitors.



#### **GRANT PROGRAMMES**

## CARE | REMEMBRANCE | RENOVATION | FUTURE

On the bases of the decision of the FHV Board of Directors, the Fund distributed endowments in the total of 14.997.177 CZK in 2010. In July, we announced the 10th call for grant proposals in our programmes Care. Remembrance, Renovation and Future. In November, the Board of Directors granted 15 million CZK for projects that shall be realised in 2011.

#### **Rules for Endowment Benefits Distribution**

In terms of the distribution of endowment benefits, the Foundation for Holocaust Victims (FHV) prioritizes organizations associated within the Federation of Jewish Communities (FJC) in the Czech Republic, followed by civic societies, public beneficial organizations, institutions established by church, public service institutions, and allowance organizations registered within the Czech Republic. The call for proposals is announced once a year, usually in July, and the deadline for projects is September. We support the projects for the following calendar year.

The projects shall be carried out within the territory of the Czech Republic. Our priority is to support projects with multiple sources of financing and a minimal share of their own or other resources to the amount of 10%. in the case of allowance organizations the minimum share is 50%. and in the case of legal entities for the purpose of business, the minimum share is 80%. Within the Care and Renovation Programmes, the maximum amount to apply for is not stated. The maximum amount of endowment benefit for the projects within the Future and Remembrance Programmes is CZK 50,000, excluding the anti-Semitism and vandalism projects. The applications shall be supplied on relevant forms, which are available on the FHV website.

The applications will be evaluated by the respective grant committee nominated by the FHV Board of Directors, and foundation benefits will be granted on the basis of the FHV Board of Directors recommendation. To obtain the foundation benefit there is no legal claim. The results of the public tender will be published on the FHV website and all applicants will be informed in writing. Successful applicants will be awarded the endowment benefit and will sign a contract with the FHV. The contract enables the verification of the use of the foundation benefit, and also, in certain cases (violation of contractual conditions), its return. The supported organizations shall present the FHV with continuous and final reports on the projects, as well as the reports on the budget. The FHV actively participates in the supported projects and informs about the projects on its web site and through the fund's info bulletin.





### **CARE PROGRAMME**

Within the Care programme, we support projects focusing on professional social, health and psychological care for Shoa survivors. At present we also support care for the needy from the second generation. The Care Programme has been a priority of FHV for many years.

Through support of a range of services and care, we aim to increase the quality of life of Shoa survivors in their senior age. We support home care, personal assistance, psychological help, residential care, day-care centres of Jewish communities, social care fieldwork, social counselling, health care, ergo-therapy, psychotherapy, physiotherapy, rehabilitation, medical care, staff on call to the clients, and activity programmes.

In 2010, we supported 16 out of 17 project applications with a total sum of 6 million CZK. Financial means to support these projects will be paid in 2011.

About a long-term supported project

## Social care centre of the Prague Jewish Community

Social-Activation services of the Social Care Centre of the Prague Jewish Community is one of the FHV's long-term supported projects. Currently, the centre works with 240 clients. The centre helps mainly those community members that are in a difficult health or personal situation. It works with Holocaust survivors and it aims to provide inter-generational dialogue. It supports care in the home environment and it helps to prevent social exclusion.

The centre offers social advisory, the helpline Dusiach, medication and medical aids subsidy from the Claims Conference Medical Fund, Health Club, the distribution of kosher food, social activities such as holiday celebrations, recreational stays or children summer camps. One of the integral parts of the centre's work is the health care in the Charles Jordan Home. The facility includes 28 small apartments, a community room and a gym. The clients of the Home are granted daily care, they can take part in ergo-therapy and social and cultural activities.

"Exercise and trips – this is our life. We like to travel together. We keep looking for new places and sights we have not seen yet, and we are looking forward to meeting new people and indeed, each other too." Clients of the "Health Club"

"The lunches from the Shalom restaurant are tasty and they come in large portions. The lunches from Hagibor follow stricter dietary laws and they help us keep slim. I am always happy to see the smile of the lady that brings them over to my house." Clients of a kosher food delivery

A resident of the Charles Jordan Home says: "In our Home, there is a very nice social worker and great nurses. The mutual relationships amongst the residents are very friendly. When I feel lonely, there is always someone to turn to. Most of us have known each other for a long time, and many of us share a similar personal history."



## **REMEMBRANCE PROGRAMME**

In this programme we support projects that help to remember the Jewish and Roma Holocaust victims in a dignified way. In addition, we support educational activities, mainly those targeted at young people – students of elementary schools and high schools – who are only starting to shape their opinions and images of the Holocaust.

Among others, we also finance publications, memorial plaques and memorials, social events, documents and exhibitions, meetings with students, workshops, research work, etc.

In 2010, we received 36 grant proposals, out of which we supported 28. The total amount of granted support in 2011 equals 503,000 CZK. Financial means to support these projects will be paid in 2011.

In 2010, 20 projects were supported within the REMEMBRANCE Programme, with the total sum of 459,496 CZK. A part of one grant was returned to the FHV.

## On a Long-Term Supported Project

## Student Field trips to the Terezin Memorial organized by the Terezin Initiative

The FHV has been supporting this project continuously since the year the fund was established. We rank highly the importance of these interactive workshops that take place in a location so central to the Czech Holocaust history.

The Terezin Initiative has been organizing and co-financing the student field trips to Terezin for 12 years. The original idea to bring more students to Terezin dates back to 1998. At that time, the site was hardly visited. The idea turned out well, and the number of young visitors is growing every year. The Terezin Initiative, thanks to financial grants of FHV, Czech Ministry of Education and the Claims Conference, can reimburse the students for their travelling costs to Terezin.

The students get the chance to learn about the history of Terezin during the Holocaust. The programme aims to work with students' stereotypes, to prevent xenophobia and Holocaust denial. The programme itself is provided by the Educational Centre in the Terezin Museum. The groups of students first listen to a lecture about Judaism, Holocaust and the history of the Terezin ghetto. After that, they go on a guided tour to the ghetto museum, they visit the most important parts of the ghetto and also go to the Small Fortress. They also watch a documentary film.

As a part of the programme, mainly during longer seminars, students and visitors have a chance to meet Holocaust survivors. These encounters are invaluable for the students, as they can listen to the personal histories of the survivors. The Terezin Initiative also offers workshops on a wide range of topics, e.g. "contemporary Anti-Semitism and Holocaust Denial" or "Bystander Effect." Students individually work on various topics and present their work at the end of the workshop.





## **RENOVATION PROGRAMME**

We support the reconstruction, renovation and preservation of Jewish monuments damaged by long-term neglect, amateur renovation practices and construction alterations or vandalism. The goal of our support is to return the monument to its original state, capturing the maximum of the architectural and artistic features, whilst at the same time accepting the possibilities of its new use.

We finance reconstructions of synagogues, cemeteries, tombstones and cemetery houses, ceremonial halls, Chevra Kadisha Buildings and houses of rabbis. We awarded grants for 20 projects to a total sum amounting 7,750,000 CZK. Financial means to support these projects will be paid in 2011.

## On a Long-Term Supported Project

The FHV has been supporting the reconstruction of the Jewish Cemetery in Mikulov since 2003. The repairs are being carried out by the Jewish community in Brno.

Jews started to settle in Mikulov in the 14th century. A local Jewish Community was established in the 15th century and it grew to be the 2nd largest Jewish community in Bohemia and Moravia until the 19th century. Since the 16th century, Mikulov was one of the centres of Jewish learning and was a home to many famous rabbis. In 1553-1573, it hosted rabbi Jehuda Löw ben Becalel, who was known as Maharal. In the 2nd half of 19th century, Mikulov Jews started to move to larger towns. On the eve of WWII, the community had only 500 members, most of whom, including the last Mikulov cantor Adolf Abraham Hellmann, were murdered during the Holocaust. The community was restored after the war in 1960, and it was included within the Brno Jewish Community.

The local Jewish cemetery was established in the second half of the 15th century and today it is one of the largest and most important Jewish cemeteries in Moravia. The cemetery includes around 4,000 tombstones. The oldest decipherable tombstone comes from 1605. Hundreds of tombstones were most probably used in the second half of the 19th century to build the barriers around the pathways in the cemetery. The most important part of the cemetery is the so-called "rabbis' hill", with the graves of the Moravian land rabbis Shmuel Shmelke Horovic and Mordechai Benet. Currently, the tombstones of the cemetery are being studied and documented by Iva Steinova and Daniel Polakovic. The documentation will be accessible to the general public. In 2008-2010, selected tombstones were erected and repaired.

There is the 1898 ceremonial hall located at the entrance of the cemetery. It was repaired thanks to the support of the FHV, and it features an exhibition about the history of the Mikulov cemetery and of Jewish burial traditions.

One of the original 3 Mikulov synagogues survives up till this date. Currently, it is being repaired. Mikulov Jewish sites are more than worth visiting.



#### **FUTURE PROGRAMME**

We support projects aiming to preserve Jewish traditions, educating in Judaism and contributing to the development of Jewish communities. The activities we support are: educational and lecturing projects, workshops and seminars, festivals of Jewish culture, thematic monthly magazines and bulletins, programmes in Jewish nurseries and schools, and other cultural programmes focusing on traditions, history and the current life of the Jewish community.

Because of growing neo-Nazi tendencies, we allocated 250,000 CZK to supporting projects focusing on the prevention of anti-Semitism and vandalism. In 2010, we reviewed 32 grant proposals out of which we selected 29, which will be supported with the total sum of 748,000 CZK. Financial means for realization of these projects shall be paid in 2011.

#### Life in Jewish communities and education in Judaism

Thanks to our support, life in most of the Czech Jewish communities becomes more vibrant and they present their activities also outside of the community. Many of the organized activities are aimed not only at the community members, but also at the wider community outside of children and students. They have a chance to learn more about the Jewish culture, traditions and customs.

For many years, we have been supporting various educational and social activities in the Jewish communities in Decin, Teplice and Ostrava. We support holiday celebrations which give a chance to the community members to meet; exhibitions on Jewish topics that are aimed at the wider public and student visitors, lectures and seminars, Hebrew instruction and other cultural programmes. These activities bring life not only to Jewish communities, but very often to synagogues and other Jewish sites.

The Jewish community in Teplice has been running their community club since 2004. Every month, there is at least one lecture about Judaism, there are debates with students, film screenings, Torah classes, exhibitions and trips. The Jewish community also includes topics of national minorities in their programme. For several years, they have been organizing meetings of national minorities together with the Hungarian, Slovak and Roma Teplice residents.

In the Jewish community of Ostrava, the main focus of the programme is on lectures. The topics of these vary. Currently, they run a series of lectures on Kabala. This topic is very attractive not only for the community members, but also for people from the outside the Jewish community. The lectures take place once a month. In addition, the community organizes trips, during which the attendants have a chance to learn more about significant Jewish personalities from the history of Moravia and Silesia. Since 2007, the community runs the children's club "Chaim" that introduces the topics of Jewish holidays to children in a fun and playful way.

The Decin community, and the local synagogue with its rich cultural and social programme, makes the site the most important Jewish centre in the Usti nad Labem region. The visitors of the cultural and educational events have a chance to learn about the history of the synagogue and its reconstruction. The Jewish community outreaches to the elementary and high-schools with lectures, debates and exhibitions on Jewish topics. The community also organizes holiday celebrations for its members.



#### **FINANCIAL REPORT**

As of the record date, 1 September 2009, the FHV merged with the CCNV. As of 31 August 2009, a financial statement for both foundations was completed. Thereby, the 2010 accounting period of the FHV presented in this annual report does not correspond to the calendar year, but to the period from 1 September 2009 to 31 December 2010.

The State Property Fund (hereinafter, as SPF) endowment benefit of year 2000 amounted to CZK 300,000 thousand. The first part of the financial means is invested in CSOB Asset Management, a.s. The second part was, until April 2010, invested in a Balanced fund of foundations in Pioneer Investments, a. s. In May 2010, the fund carried out a change of portfolio and invested this second part of financial means into Conseq Investment Management, a. s.

Besides the SPF means, thanks to the merger with CCNV, the FHV received stock amounting to 3,265,000 CZK (as of 31 December 2010), which, even after the merger, remained in the Ceska sporitelna portfolio. Granted endowment benefits in 2010 amounted to CZK 15,000 thousand, and 30 % of administration costs, in accord with Addendum no. 3 to the agreement with SPF, amounts to CZK 4,449 thousand. In order to state the total costs of running the FHV, we first subtract the costs connected with stock handling. The total running costs for 2010 are 2,922,000 CZK, which equals 19.5% of the allocated grant money, i.e., the FHV fulfilled the conditions stated in the contract about the usage of the monetary means from the SPF, and a criterion which has its basis in the law no. 227/1997. This criterion states that the running costs mustn't exceed 30% of the allocated grant money. Both this criterion and the contract were therefore met.

#### **AUDITOR'S REPORT**

#### FOR THE FOUNDER AND THE BOARD OF DIRECTORS OF THE FHV

## A report about verification of the annual report

We investigated the concord of the annual reports of the FHV and the final balance included in this annual report. We verified it, and on 6th June we issued a Report of an independent auditor in the following wording: "We verified the final balance of the FHV, i.e. the balance as of 31st December 2010, Statement of profits and losses for the period of 1st September 2009 - 31st December 2010, and the appendix of the balance including the description of the accounting method used. The basic information about the fund is listed on page 1 of this balance.

### Responsibility of the corporate body for the final balance

According to the Czech law, the responsibility for the creation of the final balance and for the true information presented in the final balance lies within the corporate body of the FHV. Within this responsibility, the corporate body has to ensure internal regulations that will make sure that the financial situation and accounting subject of the annual report are written correctly without errors or frauds; they have to make sure the accounting methods used in the fund are chosen appropriately.

## Auditor's responsibility

Our role is to issue an auditor's report. We carried out the report in accordance with the law concerning auditors and in accordance with the international auditing standards and relevant other regulations of the Chamber of Czech auditors. In accordance with these laws, we are obliged to keep ethical norms and to carry out the audit without errors.

Within the audit we used techniques that aim to discover information about sums and facts included in the final balance. The methods used are chosen by the auditor, bearing in mind he or she has to balance the methods according to the risk of expected mistakes or frauds included in the balance. When judging these risks, the auditor takes into account the relevant internal supervisory accounting means. The auditor judges these means in order to plan his audit, not in order to judge the effect of the supervisory accounting means. The audit includes judging the relevance of used accounting methods, feasibility of accounting estimates carried out by the leadership, and judging of the overall presentation of the final balance.

We presume that we managed to collect a relevant basis for the auditor's statement.

#### Auditor's statement

In our opinion, the financial statements give a true and fair view on the assets and liabilities and the financial situation of the FOUNDATION FOR HOLOCAUST VICTIMS as of 31st December 2010; and costs, incomes and outcomes of its functioning in the period of 1st September 2009-31st December 2010. The financial statement is in accordance with the accounting law and respective regulations.

The responsibility for accuracy of the annual report rests with the corporate body of the FHS. Our task is to issue a statement about the accord of the annual reports with the final balance.

We carried out the validation according to the accounting law and the international auditor standards and other relevant regulations of the Chamber of Czech auditors.
These standards require that the auditor plans and carries out the audit in a way that ensures a high degree of certainty that the information included in the annual report relevant for the final balance is in accord with the final balance. We presume, that the verification carried out represents a valid basis for the auditor's statement.

A graduate of the Faculty of Electrical Engineering of the Czech Technical University in Prague and the Czech Technical University with a major in Physics and Acoustics, Professor Kolmer is a survivor of the concentration camps in Terezin, Auschwitz and Friedland. From 1949 till 1991, he worked in The Research Institute of Sound, Picture and Speaker Technology in Prague as a scientist, and later on as the Head of the Acoustic department, Scientific Vice-Director and Director of the Institute. After his retirement, he worked as an advisor to the Director of the Institute.

Since 1962, he has collaborated with the Czech Technical University, later with the Film and TV School of the Academy of Performing Arts as a teacher of Acoustics, and since 1982, with the academic title of Professor, he has still been teaching at this school. He is the author of many publications and gives lectures all over the world. Lately, he has mostly been giving lectures on Czech-German relations during WWII, and on the life in the concentration camps. to German schools and Christian-Jewish Societies in Germany. He holds several state awards and is an honourable member of several scientific societies in the Czech Republic and abroad. Currently, Professor Kolmer is a Vice-President of the Internationales Auschwitz Komitee. vice-chairman of the Czech Auschwitz Committee, is a member of the Board of the Bundesverband für Information und Beratung der NS-Verfolgten in Cologne, Germany and a member of the Board of the Terezin Initiative, the Board of Directors of the Czech Association for the Victims of Nazism. the Council of the Federation of Jewish Communities in the Czech Republic and a member of the Czech-German Board of the Ministry of Foreign Affairs of the Czech Republic and Germany.

#### Vice-chair

## Ing. Michal Klima

Graduated at Czech Technical University in 1984. Till 1989 he worked as a computer programmer. From 1990 to 1997 he was head of Lidove Noviny publishing. From 1998 to 2000, he was the executive director of Economia, the publisher of Hospodarske Noviny and Ekonom, the weekly and monthly specialized magazines. In 2000, he established and later managed for three years an internet publishing. Economia Online, managing the website iHNed. cz. From 2003 to 2009 he was CEO of Economia publishing. Since 2007 he has been chairman of the board of directors of the Slovak publishing house Ecopress, and, since 1997, also a vice-president of the World Association of Newspapers (WAN) seated in Paris and Darmstadt. In 2003 he bought a decaying building of the former synagogue in Hartmanice na Sumave, established a civic association that reconstructed the synagogue. and runs a monument that reminds us of the co-existence of Czechs, Germans and Jews in the Sumava region. He publishes political commentaries and articles mostly focusing on the problems of the media in newspapers and magazines. Occasionally, he gives lectures in the Czech Republic as well as abroad. His wife works for the National Gallery, his daughter studies at a university in the USA and his son studies at secondary school in Prague.

## Prof. Tomas Kosta (since 1st June 2010)

He was born in Prague, During WWII. he was in Terezin. Auschwitz and Buchenwald. He ran away from a death march twice. His shortterm, after-war affair with communism ended when his parents were imprisoned during the political trials in the 1950s. At that time, he worked as a cook and archive worker. From 1953 he worked in the field of publishing, and in 1968 he became the head of the Svoboda publishing house. In August 1968. he emigrated to Switzerland and later to Germany. where he established himself as a publisher and became an influential player in the German political scene. He supported mainly the German Social Democrats, Writers such as Günther Grass and Heinrich Böll, or politicians such as Willy Brant and Johannes Rau were his close friends. Since 1990, he has lived both in Prague and Frankfurt am Main. In the Czech Republic, he used to publish the newspapers Zemske noviny and Slovo. He worked as an advisor concerning German speaking countries to the MPs Spidla, Gross, Paroubek and Fischer, Currently, he is an advisor to the minister Schwarzenberg. He is a member of the Czech PEN club. In 2002, he was honoured with the Commendation Ribbon by President Havel. In 2009, he was one of the key attendees at the Conference About the Fate of the Property

and landscape art. He has published a wide number of scientific articles and lectures. His landscape architecture qualification endows him with a nationwide perception and resolution of the tasks associated with the protection of cultural and natural heritage. He worked as a specialist at the Monument Protection Institute in Brno, later becoming its director, and from 1995 to 2006 he worked as a Deputy Minister of Culture, and later as a General Director of the National Institute for Monument Care and a Director of Matana. a.s.

A graduate of the Faculty of Arts of Masaryk University in Brno, with a major in ethnology and the history of art. She has worked in the Czech Radio music section, further as Brno Jewish Community Secretary. Currently working in public relations. Representing the Brno JC in the Federation of Jewish Communities of the Czech Republic, Dr. Peliskova is married and has two adult sons.

## Mgr. Michal Sedlacek

Deputy Director of the Ministry of European Affairs, until February 2009 he worked as a Deputy Director of the Ministry of Labour and Social Affairs.
