I come from a mixed marriage. My parents divorced in 1932. My mother was called to Cn Transport to Terezín on 17 January 1943. On 26 January 1943, she continued from Terezín to Auschwitz, where she later died in a gas chamber. My mother only brought us up in her younger years, but her wisdom and philosophy of life got deep into our hearts and souls. It stood for a source of energy that helped us overcome emotions and hardship in our later lives. She gave us so much love that we could share it forever.

The meaning of life is to keep our hearts open to everything that is human in its character, including disappointment, loneliness, sickness and death... If you are thirsty for life, everything is possible, though, there must be God's help and strong will.



#### Prof. Tomáš Radil

I was deported to Auschwitz-Birkenau when I was thirteen and half. Most of my family members died there. I became a physician and scientist working for the Czech Academy of Sciences devoting my studies to experimental research of the brain and the social psychology of mass societal crisis, catastrophes and genocides. Fundamental is not to forget what happened during the Holocaust and actively prevent mass genocides and wars from happening again. These genocides and wars repeat themselves, only in different forms and with presenting of different threats. The victims deserve respect!

"I lived upon this earth in such an age when folk were so debased they sought to murder for pleasure, not just to comply with orders." Radnóti Miklós



#### JUDr. Hanuš Gaertner

Terezín Ghetto. On 19 December 1943 he was transported to Auschwitz-Birkenau. From there to Schwarzheide at the beginning of June and in April 1945, in a death march, to Varnsdorf. At the end of WWII he was in Litoměřice.

I wonder, how is it possible that the mass murderer, A. Hitler, is still featured in many films and is presented as a character of many books. I think such a person shall be forgotten rather than "famous". Holocaust is the biggest mass murder of the innocent people in the history of mankind. It killed my father and 15 closest relatives. I hope it will never repeat again. We have to do everything for Holocaust never to happen again. The freedom and humanity must be our priority.



#### Miluška Ottová, roz. Nováková

I was born in Ostrava in August 1943, in a mixed Czech-Jewish family. From autumn 1943 to May 1945 I was kept hidden from Nazi staying by a family in the countryside. "Thanks God, the end of the war is coming and I am two years old and have both parents." From 1945 to 1977 I lived in Jeseník. In 1977 I married and moved to Olomouc. I had all sorts of jobs such as bookseller and guide in the caves. Today, I am retired. I am a district secretary of Czech Freedom Fighters Union and a coordinator of the Living Memory Project.

I wish that Shoa never repeats again and I wish for everlasting peace.



#### Ing. Václav Choděra

From my birth till the end of WWII I was kept hidden in a dark room along with a mother whose parents and all 5 siblings died in concentration camps.

I belong to the group of children hidden from Nazi persecution during the times of the Holocaust. This was the reason why I later became very engaged in the Hidden Child Association run under the patronage of the Federation of Jewish Communities in the Czech Republic. For many years, I was a member of this Association and within the last 5 years I worked as its chairman. Last year, I finished at this post, but I try to remain the regular member of this Association and other Jewish associations and organisations associated under Prague Jewish Community.

I consider the support of the people who share a similar destiny as very beneficial. To be able to discuss their problems without psychological barriers or to help each other either in the time of illness or social emergency or when doing the shopping or cleaning. It is very important. I am happy I could be helpful to all the people and I will do it till my age or health allow it.



### Edita Jindrová and Věra Štinglová, Arnstein's sisters

"Our" transport, which took us from Prague-Bubny train station to Lodž carried 1,000 people. Only 96 of them survived. We were so lucky that there were three of us in that count. Two daughters and our mother. Our father remained in Auschwitz. We have to be thankful to our destiny that we were given that chance. It was "only" our father who died. There were other 36 relatives who died, too. However, we returned. Our mother lived up to the age of ninety and me and my sister we are both ninety, too.

One should not constantly come back to the war times... Though, this cannot be left behind in the cloakroom. When we returned, the topic of war was practically a taboo. Later, when the children started to ask questions, the topic came alive again and became part of our lives - our key to the choice of literature we read, our attitude when it comes to other people's complaints, our help in the hard times or for small simple things that many people take very seriously. Our life today is a bit slower, our hearing is worse, we move with a lot of difficulty, but we are still alive. One has to thank to his or her destiny book, every day, especially when our children come around, our grandchildren and our great-grandchildren.

We are afraid of our short memory. As Ludvík Aškenázy wrote: "Each young generation may leave the nest ready for their lives hardened by the experience of their fathers and grandfathers, but these generations simply have to try it all over again and again."

... Hope they do not have to try it all again!

#### Forewords of the Chairman of the Board of Directors

In 2018, as in the past years, the Foundation for Holocaust Victims (FHV) kept fulfilling its mission through four main programs – Care, Remembrance, Renovation and Future, which are described in more detail as part of this report. The FHV has long been providing help to the survivors of Nazi persecution, reminded the public of the criminal background of the Nazi regime against the Jewish people and other racially persecuted groups and fought xenophobia. The biggest proportion of FHV financial investment goes to saving of Jewish cultural monuments, which were destined to deteriorate during the WWII and Communist regime. Had there not been any care after that era, the majority of those monuments would have ceased to exist. Thanks to the financial aid of the FHV, the restored synagogues once again decorate our cities and towns and the restored graveyards remind of Jewish settlement in our country.

The distribution of financial means is done transparently, i.e. on the basis of public calls for proposals. The use and documentation of the grants as well as other economic management of the FHV are audited by an independent auditor. The major part of the funds, which are distributed by the FHV comes from the state budget and is assigned for the time period from 2015 to 2019. Therefore, in 2018, the Board of Directors already started negotiations with the representatives of the government on the prolongation of financing by another five years, so that the activities of the FHV could proceed within the current extent after 2019.

Apart from financial support of activities supplied by third parties, the FHV fulfills its mission by organising a whole range of its own activities. The FHV holds seminars for professionals, co-organises Holocaust Remembrance Day meeting on the grounds of the Senate of Czech Parliament and other events.

I would like to thank to all donors who supported the financing of the FHV and whose names are mentioned in this report. Each and every crown was used effectively and in harmony with the aims of the FHV.

The long-term activities of the FHV would not be possible without volunteers and unpaid activities of the members of the Board of Directors and Supervisory Board and without the qualified and dedicated work of the FHV staff. I would like to thank to all of you and I believe that the activities of the FHV will carry on in the following years and that the FHV will continue to play its irreplaceable role in favour of the Jewish community and all society.

## **Mission Statement and Activities**

The FHV was established on July 31, 2000 on the basis of the recommendation of the "Joint Working Committee Focusing on Mitigating Some Property Injustices to Holocaust Victims". On September 15, 2000, based on the governmental proposal, the Chamber of Deputies of the Czech Parliament made a decision to transfer funds, amounting CZK300 million, over to the Foundation for Holocaust Victims.

In the years 2001–2005 we administrated the Compensation program, in which we distributed CZK100 million among those, whose property in today's Czech Republic had been confiscated during WWII on the basis of racial laws and who were unable to retrieve it or receive compensation through the then applicable restitution laws or international agreements. The program has been closed for several years now and our Foundation is currently not dealing with claims of this kind in any way.

education in Judaism and the development of Jewish communities and since 2013 also in the sub-programme **Our Future**, projects for Jewish families with children.

We support the projects by organizing our own activities, especially by organizing expert seminars for social workers, carers and psychologists of Jewish organizations, Mechanchim for Jewish teachers, lecturers and community workers. We are also focusing on community development, preparing the café sessions and celebrating Hanukkah in public spaces. We present the individual projects in Chapter 9.

In December 2014, the FHV signed an agreement with the Ministry of Culture of the Czech Republic on a five-year financing period in which a yearly endowment benefit, amounting CZK20 million, will be transferred to FHV's account.

We inform about our activities on a regular basis through our website www.fondholocaust.cz and the FHV also runs its own Facebook profile.

We are a member of the Association of Foundations of Donors Forum (www.donors-forum.cz/asociace-nadacnich-fondu) and of the International Auschwitz Committee (www.auschwitz.info).

## **Grant Programs**

#### Care, Remembrance, Renovation, Future and Our Future

The Foundation for Holocaust Victims supports projects based on a public tender. The call for proposals is announced once a year, usually in July, and the deadline for projects is September. The projects are realized during the following year.

FHV supports projects prepared especially by organizations under the umbrella of the Federation of Jewish Communities in the Czech Republic, associations, public beneficial organizations, institutions established by the church, public service institutions, and allowance organizations. All organizations must be registered in the Czech Republic. Natural persons are not entitled to ask for benefits.

We only support projects that are realized within the territory of the Czech Republic. The endowment benefits are granted for a period of 11 months, and in case of Care program the period is one calendar year. We favor projects having various financing sources.

In Care, Remembrance and Renovation Programs, there is no limit for a maximum requested amount. The maximum amount of the endowment benefit within the Future and Our Future programs is CZK100,000.

All applications are processed through Grantys – an Electronic Grant Database at www.nfoh-granty.cz.

The applications are evaluated by the respective grant committees nominated by the FHV Board of Directors. The Board of Directors grants endowment benefits on the

basis of their recommendation.

There is no legal entitlement to the endowment benefit. The results of grant call are published on the FHV website and all applicants are informed in writing. We sign contracts with all of our successful applicants. Afterwards we follow and review the use of the monetary means during the implementation of the project. In case of any violation of contractual terms and conditions, we demand the return of the granted money. The supported organizations present the FHV with progress and final reports on the projects, as well as reports on the budget. All projects are subject to an audit. We actively participate in projects we supported and in case the beneficiary asks, we help with the promotion of the project.

Projects in the Reminder, Renovation and Future (including the Our Future sub-program) are funded by the Ministry of Culture subsidies, the Care program is financed from our own financial resources and the donations we receive.

In 2018, the FHV and the financial means from the subsidy received from the Ministry of Culture of the Czech Republic supported 121 projects.

On November 26, 2018, the FHV Board of Directors selected 120 projects that will receive a support in 2019 in a total amount of CZK21,986,292.



# Care Program 🕛

For the seventeenth year in a row, we have been supporting projects that provide professional social care, health care and psychological care for Holocaust survivors and their families. Through collaboration with professionals, we strive to improve the quality of their lives and provide the best care at their old age. We shall not forget about the survivor's second generation. We financially support home care, nursing services, psychological aid, residential care, day care centers run by Jewish communities, social workers, social advisory services, personal assistants, medical care, occupational therapy, physiotherapy, rehabilitation, phone contact services and many other activation programs.

The care for Holocaust survivors and their families has been our priority since the Foundation for Holocaust Victims was established. We actively cooperate with the Federation of Jewish Communities, which coordinates the financing of care from the Claims Conference in the Czech Republic. In total, we support the care for about 350 clients.

#### **Overview of Granted Endowment Benefits in 2018**

In 2018, we granted endowment benefits in a total amount of CZK3,988,271 and we ran 16 projects. The amount includes the unused benefits from the previous year.

We finance commemorative events and commemoration services, exhibitions, theme lectures, workshops, research papers, and releasing of books and publications.

We support the restoration and maintenance of Jewish monuments throughout the Czech Republic. Our goal is to restore the monument to its original state when the monument was built or, if this is not feasible, we then restore the monument to the state that would capture the maximum of the architectonic, artistic and artisanal elements.

We finance the repairs of synagogues, rabbinic houses and Jewish cemeteries, re-erection and repairs of knocked-down tombstones, restoration of valuable tombstones and reconstruction of fencing walls. Our financial means do not enable us to restore all tombstones, so we also support cemetery documentation in order to have a digital image of its look saved for the future generations. All projects are lead and supervised by professionals.

## **Projects of Our Own**

We support the development of Jewish communities in the Czech Republic not only financially, but also materially, especially by organizing our own educational seminars, and cultural and community programs.

#### We Educate

#### **Seminars for Workers in Social Services**

Care for survivors and their families are our top priority. We have been organizing regular education seminars and meetings of social workers of Jewish communities in the Czech Republic. We prepare seminars with the accreditation of the Ministry of Labor and Social Affairs. Since 2014 we have also been running seminars with experts from abroad. We prepared two seminars this year.

The theme of first seminar "Updates in the Act on Social Services and Additional Information from the Field of Social Services" was lead by Jana Wichsová, the head of the Social Department of Prague Jewish Community. Dr. Martin Thiel spoke about the current situation in the area of Ghettorente payments, Dita Šnajdrová had a speech on Claims Conference grants, and last but not least, we dealt with the current situation and needs of particular communities. 13 people participated in the seminar.

The second seminar was lead by Moshe Teller, an art therapist and specialist from Jewish Care, a Centre for Holocaust Survivors in London, who has been working in the area of care focusing on mental health and the Holocaust since 1988.

The topic of the seminar was "Holocaust Awareness when Working with Holocaust Survivors and Refugees and Memories of the Refugees". Moshe Teller gave a speech on the influence of the Holocaust on the lives of the survivors, how does a Holocaust project into their everyday life in their old age and what impact does it have on relations with their children. The participants of the workshop practiced search for solutions when providing care. They followed case studies and practiced various approaches applicable to their clients. The afternoon part of the seminar was devoted to the topic of "remembering vs. forgetting". The total



number of participants of the seminar was 30 people. We would like to thank American Jewish Joint Distribution Committee, The Conference on Jewish Material Claims Against Germany, The Federation of Jewish Communities in the Czech Republic, The Federation of Jewish Communities in the Czech Republic and to Public Benefit Association supporting the People Affected by Holocaust for their support. We also thank the Jewish Museum in Prague for providing us with seminar facilities.

# Mechanchim Seminar for Teachers and Workers of Jewish Educational Organizations

Another of our ongoing projects is the "Mechanchim" seminar, the seminar for teachers and madrichs of Jewish schools, kindergartens and community workers of Jewish communities. In 2018 the seminar was already held for the sixth time. With respect to the seventieth anniversary of establishing of the State of Israel we decided to pay our attention to reasonable and non-dogmatic education on Israel.

The first day of the seminar was led by Shelley Kedar, a Shlichim coordinator sent to educational institutions of particular Diasporas by Sochnut. The participants jointly thought about the challenges of educating on Israel within constantly changing conditions of the current Jewish world and they all were shown activities that could be applied in their classrooms or community programs.





The second day was led by Nic Abery, an expert on Jewish programs involving work with the art and museum artifacts. 36 teachers and community workers from various Jewish communities around the Czech Republic and other friendly organizations attended the seminar. The feedback revealed heightened interest and pointed out the benefit of such kind

of seminars aimed at the common meeting of teachers and sharing their experience. Participants also appreciated the innovative approach of both lecturers.

Mechanchim seminar was supported by American Jewish Joint Distribution Committee, the Foundation of Jewish Community in Prague. Jewish Museum in Prague kindly provided us with their facilities.



## We Remember

## The Holocaust Remembrance Day and the Prevention of Crimes Against Humanity

In cooperation with the Federation of Jewish Communities of the Czech Republic we organized, for eleventh time in a row, commemorative event on the occasion of the Holocaust Remembrance Day and the Day of Prevention of Inhumane Crimes on the premises of the Senate of the Czech Parliament. The meeting was held under the auspices of the President of the Senate. Mr. Milan Štěch, who also gave a speech. Other speeches were given by the Chairman of the Lower House of Czech Parliament. Mr. Radek Vondráček. Holocaust survivor. professor Tomáš Radil, Roman community representative, Ms. Růžena Ďorďová, cardinal Dominik Duka, FHV Chairman, Mr. Michal Klima, and the Chairman of the Federation of Jewish Communities, Mr. Petr Papoušek. The meeting was attended by tens of Shoa witnesses, ambassadors, representatives of Czech administration and cultural institutions and students of Lauder schools. We would

like to thank the Senate of Czech Parliament and the Federation of Jewish Communities, Prague Jewish Community and the Ministry of Culture of the Czech Republic for their cooperation and support.

## Visit to Auschwitz

In cooperation with Prague Jewish Museum, Auschwitz Historical Group and International Youth Meeting Centre in Oswiecim we have been preparing a new project – a trip to a former extermination camp in Auschwitz-Birkenau. The witnesses of the Holocaust will accompany the participants and there will be an educational program.



## We Meet

## I am Jewish and I Prosper – Café Sessions

In 2018 we continued organizing community café sessions "I am Jewish and I prosper." There were two such sessions organized last year – a Café of Three Generations with professor Tomáš Radil, Pavel Štingl and Tereza Váňová and a panel session with Klára Kalibová and Janek Rubeš. The moderator of both sessions was Irena Kalhousová. We changed the venue in 2018, the sessions were held in a dynamic and developing cultural place of Hybernská Campus. Our 2019-café sessions shall focus on introducing interesting personalities of younger generations of Jews.



The café sessions are recorded on a video and are available on our YouTube channel. American Jewish Joint Distribution Committee and Prague Jewish Community Foundation support the project.

## **Chanukah Benefit Concert**

On December 6, 2018, we organized a Chanukah benefit concert. The moderator of the festive evening was Ester Janečková, the group of the benefit concert was Mackie Messer Klezmer Band and rabbi Karol Efraim Sidon lighted the Hanukkah lights.

We welcomed 200 participants, including children who were cared for by madrich Ben Hess. The profit from the benefit concert amounting CZK45,458 will support the Karlovy Vary Jewish Community care services in 2019.



# **Grant of the Ministry of Culture** of the Czech Republic

On December 18, 2014, the FHV signed an agreement with The Ministry of Culture of the Czech Republic on a long-term partnership on a project called "Provision of Endowment Benefits in FHV Programs – Renovation, Remembrance and Future." We have been successfully implementing the project for the fourth year.

Based on an approved statement of subsidy in 2017, on May 14, 2018, we received an Approval of the Ministry of Culture on a provision of a non-investment subsidy from the state budget amounting CZK20 million for the calendar year 2018.

With a use of the financial means from the subsidy we funded all projects in the Renovation, Reminder, and Future programs (including the sub-program Our Future). Out of the granted CZK20 million we did not manage to use CZK227,390. In total, there were 105 projects financed by the Ministry of Culture grant. The funds also covered the FHV administrative costs.

Audit byl proveden v souladu s platnými předpisy České republiky, především se zákonem č. 93/2009 Sb. o auditorech a Mezinárodními standardy, zejména v souladu s Mezinárodními standardem pro ověřovací zakázky ISAE 3000, a v souladu s podmínkami pro udělení dotace.

#### Přehled provedených prací

V rámci auditu jsme provedli následující práce:

- Ověření skutečnosti, že byly zaúčtovány pouze způsobilé výdaje
- Ověření skutečnosti, že vykázané způsobilé výdaje byly ve stanoveném období uhrazeny v souladu s podmínkami právního aktu
- Ověření skutečnosti, že předmět dotace odpovídal schválenému plnění
- 5. Ověření skutečnosti, že byly dodrženy ostatní relevantní podmínky právního aktu

#### Závěr

Na základě výsledků použitých auditorských postupů jsme nezjistili žádnou významnou skutečnost, která by naznačovala, že účetní záznamy nebyly vedeny v souladu s platnými zákony a podmínkami hospodaření se státní dotací určeným příslušným rozhodnutím. Organizace sestavila přiložené Vyúčtování nákladů projektů za rok 2018 v souladu s účetnictvím. Celkové vykázané uznatelné a zároveň dotované náklady projektů činí 19 772 610,00 Kč. Podle našeho názoru toto Vyúčtování nákladů dotace ve všech významných ohledech věrně zobrazuje náklady výše uvedených projektů a hospodaření s touto dotací je v souladu se stanovenými podmínkami.

## **Financial Report**

The FHV financial report was assessed for a period from January 1 to December 31, 2018.

In 2000, the FHV received an endowment benefit amounting CZK300 million from the former State Property Fund, today's Ministry of Finance of the Czech Republic. These financial means are distributed in harmony with the stated grant rules on a yearly basis. A large proportion of these financial means have been distributed as part of the endowment benefits; the remaining CZK41 million is invested in shares. These funds are administered by the Conseq Investment Management, a.s. and ČSOB Asset Management a.s.

On January 29, 2014, the contract on the transfer and use of financial means between the FHV and the Ministry of Finance of the Czech Republic was terminated. All of the unused funds remain in the administration of the FHV; the funds will further be administered as FHV's own funds.

In 2018, in the 17th call for proposals, a total granted amount was CZK21,261,000. Out of this sum CZK17,273,000 was financed by the subsidy of the Ministry of Culture and CZK3,742,000 was financed from the FHV's own means. The remaining CZK246,000 was paid from the donation of the Public Benefit Society to support people affected by the Holocaust and the Public Collection.

The FHV administrative costs in 2018 amounted to CZK3,742,000. Out of this sum CZK997,000 was paid by the FHV from its own funds, CZK2,500,000 from the subsidy of the Ministry of Culture and CZK245,000 was paid from other external sources.
